Objectives and Investment Policy

The Fund seeks to replicate (with a maximum tracking error* of 1%) the performance of the MSCI Pacific ex Japan ex Controversial Weapons (NTR) Index (the «Index») by investing in shares issued by companies included in the Index, respecting the Index's weightings (full replication), or in a sample of shares issued by companies included in the Index.

When investing in a sample of shares, the Fund's tracking error may be higher.

*The tracking error is a risk indicator that measures how closely a fund tracks the performance of its reference index.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).




Charges
